### Notice of intention to defend; Drafting and written communication - Pleading

#### Overview

You should develop knowledge and understanding of:

- The rules in relation to pleadings in general and to the rules which apply to each particular form of pleading.
- Pleadings, that is, the documents which the parties to litigation (the plaintiffs and defendants) exchange with each other to establish the material facts that they believe support their case. These will include:
  - Claim
  - Statement of Claim
  - Notice of Intention to Defend
  - Defence (and Counterclaim)
  - Reply (and Answer).

#### 1. Approach to Learning

3. **UCPR Forms** - review carefully:

- a. Form 6 - Notice of Intention to Defend;
- b. Form 7 - Conditional Notice of Intention to Defend, and
- c. Form 8 - Notice of Address for Service.

Aim to become familiar with finding your way around the Courts' Website as this will be a very useful skill when you are a Graduate and looking for dates and times for matters your employer may have in Court, etc.

4. **Legislation** - Service and Execution of Process Act 1992 (Cth); Trans-Tasman Proceedings Act 2010 (Cth) - Notice of Intention to Defend.

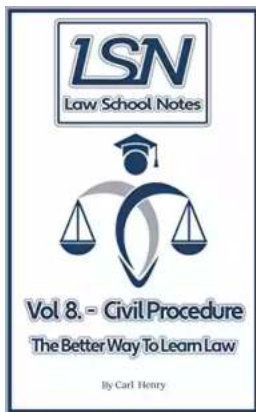

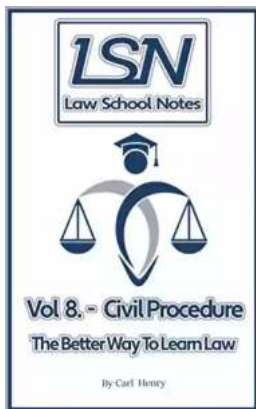

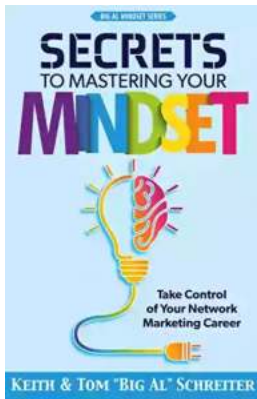
